| When children and adolescents come to counseling for support with trauma and abuse that they have experienced, clinicians can be at a loss for how best to work with the complexities and the intensity of their clients' experiences. Without a clear understanding of what to do and how to facilitate the integration of children's traumas, children can stay stuck and unable to move forward in their healing. Clinicians can also find themselves anxious, exhausted, confused, overwhelmed and dysregulated, which can over time significantly impact their longevity in the field, as well as their ability to stay attuned and present to the child. With the help of neuroscience and a Synergetic Play Therapy framework, this two-day workshop will teach clinicians how to effectively work with trauma and abuse in a way that supports integration, nervous system regulation, and decreases compassion fatigue and vicarious trauma. | | | | | | | |

Note:

- 1. Application for accreditation should be filed 45 days before the offering of the program/training.
- 2. Representative/s filing application/s for accreditation and claiming the Certificate of Accreditation in behalf of the applicant must present a letter of authorization and valid identification cards of both the authorized signatory and the representative.
- 3. The period for processing the application is 45 days.
- 4. If additional requirement/s is/are needed, a period of 7 days is given to submit the same. Failure to comply within the period shall be construed as abandonment of application and the prescribed fee shall be forfeited in favor of the government.
